Commissions:



The Board of Police & Fire Commission meet at the Village Hall (11004 Carpenter Street) and Police Pension Commission meet at the Police Station (10907 Front Street) on a monthly, quarterly or less frequent basis. Specific meeting dates will be posted at the Police Station and Village Hall. In addition, each paper will receive a facsimile notification.
